Privacy Policy

International Aviation Support BV (hereafter "IAS") is a part of the AYR Global Aviation Group.

This privacy policy sets out how IAS and its subsidiaries (IAS Lelystad, AYR Global Technics BVBA) uses and protects any information that you give IAS when you use this website.

IAS will not provide any information you provide to us to any known charitable organization or political party. Your information may be shared with contractors of IAS for the purposes of performing services for IAS or for the purposes of enhancing our total performance for you.

Customized Services

If you register on-line, a technology called a "cookie" may be used to provide you with tailored information designed expressly to enhance your experience when using our website. A cookie is a tiny element of data that a website can send to your browser, which may then be stored on your hard drive so we can recognize you when you return.
